	<ul style="list-style-type: none">□ The College of Menominee Nation established guidelines to disburse 50% of the HEERF emergency aid to the following:<ul style="list-style-type: none">● Title IV eligible students● Degree seeking● 2020 Spring and Summer enrollment● \$520 for full-time students (12+ credits)● \$425 for 3/4 time enrollment (9 – 11 credits)● \$375 for half-time students (6 --8 credits)● \$200 for less than half-time students (1 - 5 credits)
