In order to meet the needs of American Indian students on and near the reservations in NE Wisconsin, CMN infuses aspects of culture in all coursework. In addition, we require two mathematics and science courses (with a lab) and focus on traditional science. We have increased special education coursework from 3 to 7 credits. We also require field experience in schools with significant numbers of American Indian students.

CMN's Teacher Education program uses various technology (Computers, iPads, Smart Boards, photo and video cameras) with editing and assistive devices for those students who require additional support. The first objective is to have teachers know how to integrate technology in classrooms within subject areas through lesson plans taught/collected in each methods class. Faculty members seek to provide students an opportunity to engage and learn from a variety of technologies in coursework. Secondly, pre-service teachers create e-portfolios to show competency by reflecting on INTASC Teacher Standards -- knowledge, skills, and dispositions. Pre-service teachers are encouraged to be creative in their presentation as well as include videos of themselves teaching. During Methods Classes, pre-service teachers engage in coursework using google classroom or Schoology and use video to show how they are able to assess children as well as reflecting on their own practice within various subject disciplines. The CMN Teacher Education Department uses surveys and forms to gather alumni and graduate data as well as to monitor data on department required assessments. In response to the COVID 19 pandemic, we have transitioned to online teaching and learning.. As a result, pre-service teachers are engaging with new technologies every day as faculty members seek to engage students via learning management systems using flipgrid, padlet, Google Meet, Screencast-O-Matic, adobe sparks, etc. We believe these experiences will coitinue to provide opportunities for our future graduates to effectively integrate technology into their future classrooms.

#### a. Teach students with disabilities effectively

CMN's Teacher Education Program includes 2 courses (Introduction to Exceptionalities and Inclusion Strategies for Exceptional Children) that are designed to not only introduce students to the varying levels of disabilities and exceptionalities but also provides strategies and methods in how to differentiate instruction and work with children with unique challenges. When creating lesson plans and creating curriculum students are asked to include adaptations and modifications that are appropriate for children with disabilities. These may include but are not limited to adaptive teaching and work strategies, materials and equipment, etc. In addition, coursework in Methods courses, and our Observation and Interpretation courses focus on differentiated curriculum, PBIS (Positive Behavior Interventions and Supports) and RTI (Response to Intervention) Processes. Culturally responsive programming and practices are infused within all professional coursework.

#### b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

Student teachers in clinical practice are required to participate in an IEP team and in IEP Meetings of the course of their 18-weeks of student teaching experience. Students are asked to participate in all facets of the IEP team meetings from inception to placement as appropriate.

#### c. Effectively teach students who are limited English proficient.

We believe part of teaching students to work with limited English proficient students is to first recognize the importance of understanding the culture and the background in which students come to their classrooms with. Our teacher education program has a heavy emphasis on culturally responsive practices in all of our coursework. Our Inclusion Strategies class and more specifically our methods of Reading and Language arts class heavily covers strategies for working with limited English proficient students.

As an institution of higher learning chartered by the Menominee People, the college infuses this education with American Indian culture, preparing students for leadership, careers and advanced studies in a multicultural world. As a Land Grant institution, the College is committed to research, promoting, perpetuating and nurturing American Indian culture, and providing outreach workshops and community service. Mission Statement of Teacher Education Program College of Menominee Nation's teacher education program prepares teachers as decision-makers who are reflective, collaborative educational leaders committed to equity and social justice for families and community and dedicated to maximizing the potential of all children, especially American Indian children. Conceptual Framework The College of Menominee Nation teacher education program conceptual design positions the teacher as the major decision-maker who continuously decides not just what is taught but how it is taught, in what context, and why. CMN teacher education program prepares the teacher as a decision-maker who plans learning experiences for children within various subject areas and creates safe and effective pedagogical environments for children to learn from each other. This learning takes place within an inquiry approach to problem-solving. With decision making being pivotal, teachers can challenge and monitor their personal beliefs and dispositions regarding social justice issues. Teaching is a process where teachers continuously assess their decision-making when planning, creating, challenging, and reflecting on children's learning and their own decisions in a constructivist environment. Philosophy of the Teacher Education Program A constructivist philosophy (focused on how learners construct knowledge from prior learning and interests) underlies CMN's teacher education program that prepares teachers as decision-makers to care, reflect, respect, take risks, and become collaborative participants in the pursuit of becoming professional teachers. The performance skills necessary for this endeavor are guided by the tribal clan structure that portrays the early social organization of the Menominee. Centuries ago, clans accepted responsibility for the security, construction, hunting and gathering, law (governance) and freedom, and justice so the community could survive and thrive. Those clans (pictured in the CMN logo) are represented by the moose for security, the crane for construction, the wolf for hunting and gathering, the bear for law (governance), and the eagle for freedom and justice. Today, those clans still function in the community in various ways. Here, for educational purposes, CMN's teacher education program matches those clan functions with the performance skills necessary for thriving in an educational community. Clan responsibilities for: 1. security means teachers obtaining a strong knowledge base for planning teaching and learning experiences to thrive; 2. construction refers to teachers building a safe environment that honors tribal "ways of knowing" and "learning together;" 3. hunting and gathering sees teachers as seeking problem-solving for learning situations – teachers guiding learners to seek information and search for reasoned arguments that explain life forces; 4. governance describes teachers as developing a governing or professional voice to communicate and collaborate; 5. freedom and justice challenges teachers to monitor their own beliefs that serve as barriers to social justice. While guided by tribal values, each of the circles in the graphical representation above envelops knowledge bases within varied disciplines that structure and provide performance competencies for: 1. reflecting on subject knowledge in planning; 2. creating respectful learning spaces that are both safe and effective environments for learning together; 3. designing experiences in problem solving, inquiry-based classroom; 4. collaborating (using professional voice) within learning communities; and 5. caring that beliefs and dispositions facilitate social justice for American Indian children and assessing student learning to support progress in the classroom. CMN's teacher education program builds a firm foundation for teacher candidates to enter the teaching profession with a strong philosophical base and new ways of thinking about the subject matter, how children learn, and how to monitor one's own professional growth. Assessment: InTasc Model Core Teaching Standards for Teacher Development and Licensure are within the CMN Teacher Education's Conceptual framework and evaluated in the Student Teaching Seminar via electronic portfolio published in the Teacher Education document room.
